St. Mary's Center for Women and Children Establishes New Role to Combat Homelessness

Narrative for Board Chair to All Staff

St. Mary's and everyone in this organization, does incredible work to fight and deal with the issue that is at the core of our mission – homelessness.

You are in the trenches, day in and day out, working with passion and perseverance, to manage its ramifications on women, children and families. You work so hard to give women the hope, skills, and confidence they need to break the cycle of homelessness and achieve sustainable economic and emotional independence.

But, as demonstrably effective that our work is here, the bigger battle is falling short! Homelessness in Boston over the past year has increased by 14%. Obviously, more needs to be done.

For this reason, and consistent with our mission, St Mary's is establishing a new role that will be dedicated to creating more awareness of this dire issue and to galvanizing broader and deeper support for dramatically reducing the state of homelessness throughout the greater Boston area.

The new role is that of CEO Emeritus, and our current CEO and President, Deirdre Houtmeyers, will assume the position effective January 1, 2020.

As the scope of the problem demands, Deirdre will be solely focused on this mission and will no longer be involved in the operations or management of St. Mary's Center. She will be working off campus and completely focused on the external role. Deirdre will report and interact exclusively with the Executive Committee of the Board of Trustees.

As a result of her acceptance of the position, the Board will immediately initiate a search for a new President. We anticipate that this search may take some time to complete.

We realize that any kind of change can be unsettling. I assure you, however, that the Board and the ELT will do all we can to make the transition as smooth as possible and will keep you informed as the process evolves. This leadership change will not affect your roles and reporting structure.

Alexis will continue to lead the day to day operations and programs until a new president or an interim president is in place. She will also continue to work closely with the outside financial consultants until a Chief Finance Officer is on board and will report directly to the Trustee's Executive Committee. Susan will continue as Senior Vice President of Development and Communications. Both will work closely with the Board during the transition.

The Board and Deirdre agree that this singular focus is necessary in the larger effort to rigorously target the ever-escalating trend of homelessness in our community. This issue has been front and center for the Board for a long time. We have also been discussing how we could even better leverage Deirdre's experience and passion on this issue. In times like these when the need is beyond great, we must act! And Deirdre has accepted the challenge!

Her responsibilities will include developing long-term partnerships with organizations that share our passion, and she will work with other leaders to influence government policy on behalf of women and children who are homeless and don't have a voice. She will also meet regularly with legislators to close the funding gap for St. Mary's programs.

The new role will be evaluated on an annual basis consistent with the budget overview.

Deirdre will work with the Board and the ELT on the transition plan through the month of November, will be on vacation in December and, as I said, assume her new role January 1.

Thank you everyone for your continued dedication to St. Mary's and its mission. Our demanding work is more important than ever and its expansion to include a dedicated focus on advocacy for the broader population of homeless people in our community comes at a critical time.
